These trailer drawings are merely a sample of what T&E has done for our current and past customers.

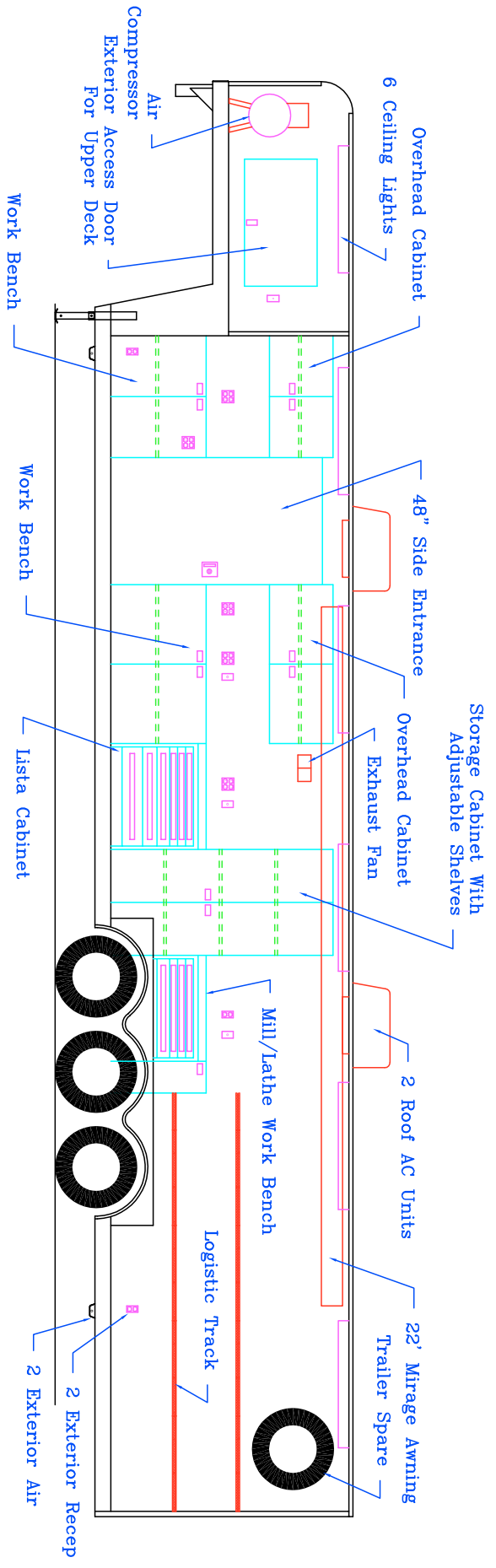

TRAILER #2 WITH LIVING QUARTERS

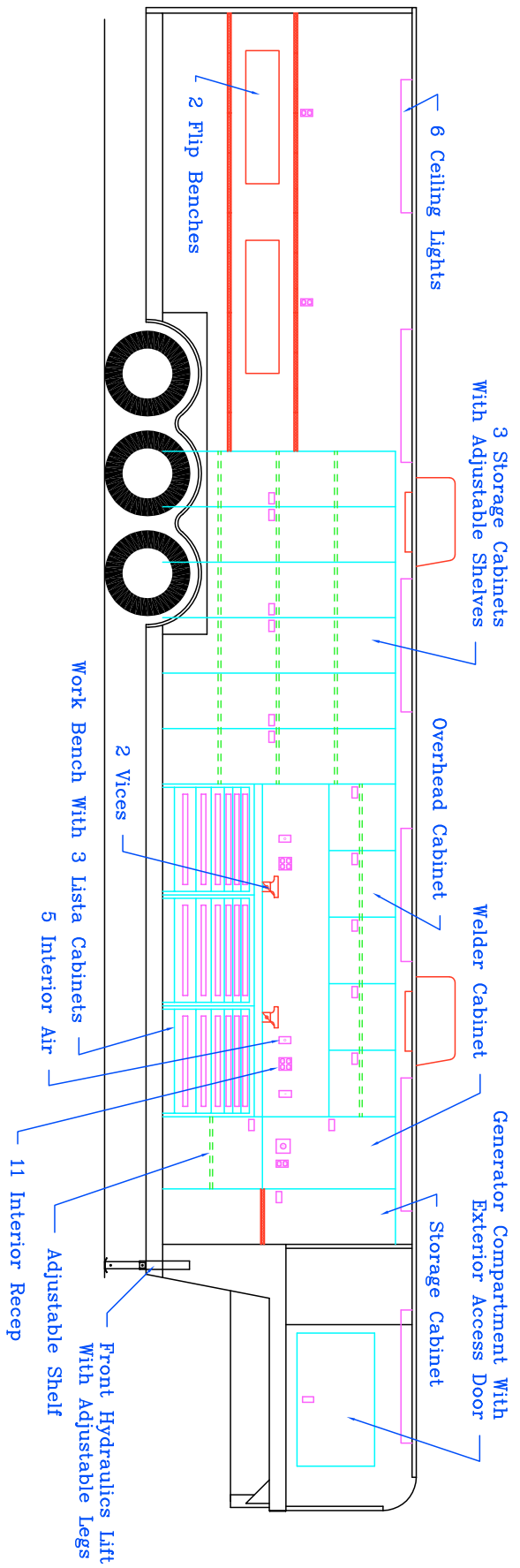
